Council was presented with a list of proposed sewer increases based on percentages. It would be cost effective to get information out via City newsletter about the new online payment option and to inform the residents about the needed sewer increase at the same time.

SEWER DELINOUENCIES

Delinquent utility accounts were discussed briefly with no action taken at this time. Council discussed the proposed sewer rate increases as presented. The last time the city sewer rates were changed was in 2010. Motion was made by Dana Boyer, seconded by Dicey Albright, to implement a fifteen percent increase of all the current sewer rates, effective February 2016 Billing. Motion passed 5-0.

Chief Boyer discussed the pros and cons of the bullet proof vests and that he would like to get at least one of the new style vests, that can be worn on the outside clothing as opposed to under, with of the cost coming from the Law Enforcement Fund. Mayor Schneider agreed the new style is much more comfortable and convenient too.
