# CITY OF MERIDEN APPROVED MINUTES CITY COUNCIL MEETING JANUARY 8, 2019

## **NEW BUSINESS**

City Auditor John Welch, reviewed the 2018 City Audit he completed and informed council that no issues were found. He also relayed that the city records were impeccable. Council had no questions, so John Welch recommended the following motion be made:

Motion was made by Floyd Cozadd, seconded by Richard White, to approve the 2018 Audit and file said audit with the State of Kansas. Motion passed 5-0.

John Welch presented a one and a two year Audit Contract for the years of 2019 and 2020, with discounted yearly totals, if council accepted the two year contract verses one year.

Motion was made by BJ Whiteman, seconded by Richard White, to accept a (2) two year Audit Agreement for 2019 and 2020, in the amount of \$8,500 each year. Motion passed 5-0.

Council reviewed and discussed the applications received in regards to the City Clerk's Assistant position. Discussion led to council forming a sub-committee, consisting of two council members and the city clerk.

Motion was made by Jackie Cummings, seconded by Ken Parker, to form sub-committee to hold interviews and make a decision on City Clerk's Assistant. Motion passed 5-0.

Motion was made by BJ Whiteman, seconded by Richard White, to offer \$13.00 per hour and increase to \$14.00 per hour after ninety days. Motion passed 5-0.

## SEWER/TRASH DELINQUENT ACCOUNTS

Margaret Higgins, tenant at Mark Kramer's property, was present to discuss her delinquent utility account with council.

Motion was made by Jackie Cummings, seconded by BJ Whiteman, to stop the late fees on Margaret Higgins utility account as she will agree to a payment agreement for \$70.00 per month plus the current billing. Motion passed 5-0.

Motion was also made by Richard White, seconded by Ken Parker to send final disconnect letters and flag for sewer dig up, on so noted delinquent utility accounts. Motion passed 5-0.

## **POLICE DEPARTMENT TIME**

Motion was made by Jackie Cummings, and seconded by Richard White, to take one-half out of the Law Enforcement Fund and one-half out of the Equipment Reserve Fund.

Motion passed 5-0.

Jason Boyer relayed City of Meriden is really dark and he would like to have a map to give to Westar Energy, showing locations in need of lighting.

#### MAINTENANCE DEPARTMENT TIME

Matt Williams presented council with the one time easement letters that were signed by Michael and Cynthia Jewell at 103 N. Palmberg Street and Michael Jenson at 105 N. Palmberg Street for the ditch needing repair and maintenance off Palmberg Street.

Mayor Boyer relayed that she did give Matt Williams authorization to have repairs made to truck prior to meeting as they were estimating the cost at around \$2,000. Matt Williams informed council of maintenance truck repair quote when received totaled around \$5,400 and relayed that he will try to fix what he can to drastically reduce this cost.

Matt also relayed that he wants to get poly-perm salt/sand mix to have on hand as well. Nothing further at this time.
