Wayne Ledbetter, County Commissioner, relayed to check covid.ks.com website for information about CARES Act and SPARKS Funding. Mayor Dana Boyer said CARES Act information had been handed out to Meriden Businesses.

From CARES Act, State of Kansas has \$1.03 billion, most money to counties around Kansas City and the rest to the state.

Jefferson County received \$3.9 million to distribute to cities and James Tweed, Emergency Service Director, Jefferson County to distribute. Biggest portion of money, about \$1.6 million to schools in (3) three implemented distributions already put aside. Meriden to receive \$60,000 and Meriden City's plan has to be in states hands by August 15, 2020. If state rejects our proposal, hope money can be reallocated.

Associate Administration will be key contacts at Jefferson County.
